

## AfPA and Pacific Global Partner for PALM Scheme, Providing Crucial Relief to Roadwork Industry Skills Shortages

The Australian Flexible Pavement Association (AfPA) has signed a Memorandum of Understanding (MoU) with the Pacifica Global Group, an international workforce solutions company, to launch a partnership aimed at delivering essential support to the roadwork industry. The partnership through the Pacific Australia Labour Mobility (PALM) Scheme, marks a significant step towards fostering innovation, sustainability, and resilience within the infrastructure and roadwork sector.

The PALM Scheme facilitates the engagement of workers from 9 Pacific islands and Timor-Leste by qualified Australian businesses during periods of insufficient local workforce availability. Under the PALM scheme, qualifying businesses have the opportunity to onboard labour for seasonal employment extending up to 9 months, or for extended durations ranging from one to 4 years.

As road networks play a pivotal role in maintaining connectivity and enabling economic growth, the collaboration between AfPA and Pacifica Global comes as a timely and muchneeded solution to address the challenges currently faced by the industry. This partnership will enable AfPA members to leverage the expertise and resources of Pacifica Global, enabling them to enhance their capabilities in tackling the pressing demands of roadwork projects as skills and labour shortages continue to stifle the industry.

Tanja Conners, AfPA's Chief Operating Officer said:

"Roads are among the most crucial assets in Australia. AfPA's commitment to the industry extends beyond just technical support, and our partnership with Pacifica Global provides exceptional opportunities for AfPA members to address workforce gaps effectively.
